

# MEMBERSHIP DEFERRAL PLAN



In consideration of the premium paid and subject to the terms, exclusions, conditions and limitations Birchbank Golf agrees as follows: Per Policy agreement April 1st to October 31st

#### **CLAUSE**

In the event of illness or injury of the member, Birchbank Golf will provide a credit towards the next seasons membership dues, power cart lease, Trackage licence and range pass subject to the following conditions:

- 1. The member must have been disabled due to an illness or injury for a period of 60 consecutive days.
- 2. A request for a credit must be made in writing and accompanied by a letter from his/her doctor stating the member's inability to golf.
- 3. Notice of claim for injury or illness must be given to the Administration Office within 30 days of the injury or illness.

### **DEATH OF A MEMBER**

In the event of death whereby the membership was a couple, the membership fee credit shall be transferred and applied to the surviving spouse's membership fees for the next season. In the event of death of an Adult Single, Junior, Student or Intermediate member, the membership credit may be transferred to an existing member of Birchbank Golf, or if requested by the estate a refund shall be given. In the case of death of an adult member of a family membership, the membership fee credit shall be applied to the surviving spouse. In the event that the surviving spouse of a Couple or Family membership chooses not to golf the following year, a cash refund will be given.

#### **EXCLUSIONS:**

- 1. A credit for membership dues does not apply for injuries, illnesses or death occurring after August 31st of the current season.
- 2. A credit for membership dues for injuries, illnesses or death only applies to adult members of a full season membership.
